Sen. Chuck Grassley Supports IFA

IFA board members read the following message from Iowa Senator Chuck Grassley during the 2019 Gala. "Thank you to Iowans for Adoption for [raising] awareness of the needs of foster youth in our state. This organization is performing very valuable work to educate others about adoption, including for parents who may not be ready or able to parent yet, for those who are waiting to adopt, for those who have adopted and for those who are waiting to be adopted from foster care.

Iowans for Adoption is also working to educate others about the need for more high-quality foster parents in Iowa and across the U.S. Research shows that providing the option of adoption to those who are not ready, willing or able to parent can reduce the risks of poverty for birth parents who opt to place their infant for adoption and for their infant.

In 2009, I launched the bipartisan Senate Caucus on Foster Youth as a call to action for lawmakers in Congress. Through my work on the caucus, I've had the opportunity to hear firsthand what children in foster care need. They need love, support, safety and permanency. They need a family. I salute all those who dedicate their time and resources to help these kids.

Last year, Congress passed the Family First Prevention Services Act, which will allow states to receive federal reimbursement for services to keep kids safely with their parents. These services include substance abuse treatment programs and directly ties into Iowans for Adoption's main goal.

While this is an important first step, more work remains. Moving forward, I will continue to work to find better solutions and secure better outcomes for youth in foster care. As your senator, it's important that I hear from you, so please continue to keep in touch!"

Birth Certificates to Adult Adoptees

Many adults whose adoptions were finalized in Iowa are continuing to support the passage of **HF746** and **SF621**. These bills would unseal and provide adopted adults copies of their original birth certificates within certain stipulations. 2019 Policy Update

Honorary Board Member, Erin Kiernan, and many adoption advocates continue to support Iowa **SF 234** and **HF30**. These bills require an employer under Code chapter 91A to treat an employee who adopts a child in the same manner as an employee who is the biological parent of a newborn child for purposes of employment policies, benefits and protections for the first year of the adoption. Federal law requires employers to ensure up to **12** weeks of unpaid adoption and maternity leave through the Family and Medical Leave Act. A few states, including California, Rhode Island and New Jersey, have included adoption in their paid parental leave programs.

Featuring Keynote Speaker Tom Vilsack



Tom Vilsack was born in a Pennsylvania orphanage where his birth mom resided until his birth. Bud and Dolly Vilsack adopted him four months later. Vilsack has dedicated the majority of his life to public service as a politician, a lawyer and a champion for strengthening the nation's agriculture industry.

After graduating from law school, Vilsack moved to Mt. Pleasant, Iowa, where his wife, Christie, grew up. This is where he launched his successful career as a trial lawyer. After the murder of the Mt. Pleasant mayor in 1986, Vilsack stepped up to serve five years as the mayor until he was elected to the Iowa Senate.

Currently, Vilsack serves as president and CEO of the U.S. Dairy Export Council, where he provides strategic leadership of USDEC's global research activities, regulatory affairs and trade policy initiatives. He took the position in February 2017 after serving eight years as the nation's 30th Secretary of Agriculture. Prior to his appointment, he served two terms as the Governor of Iowa and six years in the Iowa State Senate. He has two adult sons, two daughters-in-law and five grandchildren.
